1. Certificate regarding fully vaccinated against covid-19
2. Fully vaccinated against tetanus and Hepatitis-B virus.
3. Original Matriculation certificate duly verified by the inter board committee of the chairmen (IBCC) +5 unattested photocopies of both sides (Matric result card is not acceptable).
5. Original F.sc certificate/result card duly verified by the inter board committee of the chairmen (IBCC) +5 unattested photocopies of both sides.
6. O'level certificate & A'level certificate duly verified by the Inter Board Committee of the chairmen (IBCC) with detail sheet + 5 unattested photocopies of both sides (if applicable).
7. Original provisional/character certificate of previous college+5 unattested photocopies.
8. Five photocopies of CNIC of student& father/Guardian unattested.
9. Original Domicile certificate +5 unattested photocopies.
10. Original BMC(Board Migration certificate)/NOC from concerned Board of Intermediate & Secondary education in favour of university of Health sciences Lahore,(if the board of intermediate & secondary Education is other than Punjab province).
12. Un-attested ten recent photographs with sky blue background (passport size).
13. Un-attested five copies of Entry test result card or SAT-II examination result card.
14. One set of photocopies of all educational documents (for Boarders only)
15. Original Affidavit on RS.300/-stamp paper (specimen attached as Annexure-A)
16. Original surety bond on Rs.300/-stamp paper (specimen attached as Annexure-B)
17. Scanned documents from original (a-verified Matriculation/certificate (Both Side)
(b-verified F.sc certificate (Both Side) c-MDCAT result d-Recent picture with sky blue background), in JPG format (every Documents less than 250KB). In USB drive or whatsapp in no. 0332-7768013.
18. Upon submission of complete original documents you shall have to deposit remaining college dues amounting to **RS.62500/-** in HBL through bank Challan available in the student section of college at the time of submission of original documents.

After depositing the college fee for those students who are interested for hostel accommodation are required to deposit hostel dues amounting to **Rs.51500/-** (Excluding Mess Charges) through Bank Challan available in the college student section.

This provisional Admission is subject to verification of your documents from the concerned Board/authorities and shall confer no right of your admission in this college contrary to verification of documents.

Your Provisional admission is liable to be cancelled, changed, corrected or modified as and when necessary at your own risk and cost as advised by the chairman Admission Board/Vice Chancellor University of Health Sciences Lahore.

As per prospectus 2025-2026 page 54 clauses (v), the candidate are requires to submit a surety bond on stamp paper, worth Rs. Three (3) Million stating that he/she would serve Government of the Punjab, Health department as Probationary Medical officer/Women Medical Officer in primary Health care facilities for a period of one year after completing the foundation year/ house job. In case he/she fail to fulfill the commitment, he/she shall be liable to pay Rs. Three (3) million to the Government (Health Department Notification No. (ME)9-4/2015 dated 24th August,2015) by the candidate as well parents.

Your admission will be cancelled and you will be debarred for admission for a period of seven year, if any documents/information provided by you is found false/fake/fabricated at any stage of admission as well as during the course of study. In case of cancellation of admission/studies due to bogus/fabricated documents, original documents shall not be returned to the candidate and shall only be handed over to police/investigating agency, if required after taking qualified receipt.

You will be required to comply with all relevant rules, regulations and instruction etc, as contained in the prospectus session 2025-26 and as modified by the Government of Punjab, College Authorities & by the Chairman Admission Board/Vice Chancellor University of Health Sciences, Lahore, from time to time.

All candidates will be medically examined by a medical board constituted by the Principal DGKMC before their admission in the medical college. The Candidate must be physically & mentally fit according to the criteria for medical fitness/disability laid down by the Admission Board.

Students are advised to keep with them sufficient number of photocopies of the above mentioned documents. Original documents shall not be returned back to the students during their whole study period.

HOSTEL ACCOMMODATION:

1. Intending boarders in case of allotment will be required to submit their address and list of visitors with CNIC & three passport size photographs of the visitors (age less than 18 years) duly signed /authorized by the parents and any change thereafter will not be entertained until & unless authorized by the parents. This is with special note for girls students.
2. The intending boarders in case of allotment will sign the affidavit available in the office related to the rules & regulations of the hostel to be abided strictly for a better living and discipline in the hostel.
3. Any changes in permanent/temporary address should be communicated to the college office as soon as possible.
